On July 24, 2008, the Wisconsin Board of Nursing granted Nicole Sellers an immediate stay of the suspension of her licensed practical nurse license, (#303250) pursuant to the Board Order. This Order provided that the stay is continuous contingent upon her compliance with the terms and conditions of the Board Order.

Information has been received by the Department Monitor that Nicole Sellers is in not testing in an approved drug monitoring program and therefore is in violation of the July 24, 2008 Order.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the stay of suspension is REMOVED and Nicole Seller's license (#303250) to practice as a license practical nurse is SUSPENDED.

This Order is effective as of five days from the date of the Order to allow for mailing.
