On October 14, 2010, the Board of Nursing considered the petitioner's request for modifications to the Final Decision and Order of the Board dated October 23, 2008. Specifically, petitioner requested a reduction in her drug screens and the termination of her therapy requirement. Based upon the information of record which shows that petitioner has not been in compliance with her therapy requirement and she has not provided an explanation regarding a positive drug screen, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for modifications to the limitations upon the license of KIMBERLY RODERS L.P.N. (lic. #305658-31) to practice as licensed practical nurse is DENIED.

IT IS FURTHER ORDERED that petitioner shall not be eligible for a decrease in her drug screens until such time as she submits a satisfactory explanation regarding her positive drug screen which occurred on March 4, 2010.
