On May 6, 2010, the Board of Nursing considered the petitioner's request for a modification in the Final Decision and Order of the Board dated April 2, 2009, to reduce the frequency of her drug screens and reduction in her therapy sessions. Based upon the information presented with shows that petitioner is compliance with the terms and conditions of the Order, the Board now finds and makes the following:


ORDER


NOW, THEREFORE, IT IS ORDERED that the request for a reduction in the random drug screens for LISA M. WICKLINE, R.N. (lic. #98101-30) is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner's drug screens shall be decreased to twenty-eight (28) times per year plus one annual hair test.

IT IS FURTHER ORDERED that the frequency of the petitioner's therapy may decreased based, per paragraph C.4 of the Order, in the therapist's discretion.
