The Real Estate Appraisers Board considered this matter at its meeting on November 10, 2010.

### **BACKGROUND**

On February 25, 2009, the Board issued a Final Decision and Order with regard to disciplinary proceedings against Mr. Counard, a Certified Residential Appraiser, License Number 9-1310. Specifically, the Board's order provided, in part, as follows:

• That the Respondent successfully complete no less than 60 hours of remedial education, all to be completed within 15 months of February 25, 2009 Order.

The time for completion of the remedial education has passed and the Respondent has failed to complete the remedial education. The Respondent is in violation of the Board's order of February 25, 2009.

Based upon all the information of record, the Board orders the following:

### **ORDER**

**NOW, THEREFORE, IT IS ORDERED** that Mr. Counard's license to practice as a Certified Residential Appraiser, be and hereby is, immediately SUSPENDED due to the violation of the February 25, 2009 Board Order.
