On November 4, 2010, the Wisconsin Board of Nursing considered the petitioner's request for full reinstatement of her registered nurse license pursuant to the Final Decision and Order of the Board dated April 2, 2009, which suspended her license for an indefinite period. Based upon the information of record which shows that petitioner has not been in compliance with the terms and conditions of the order for the required five (5) years to warrant full reinstatement, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for full reinstatement of the license of DAVENE S. ROW, R.N. (lic. # 142171-30) to practice as a registered nurse in the state of Wisconsin is hereby DENIED.

IT IS FURTHER ORDERED that petitioner may not submit a petition for modification of the order until she has one (1) year of compliance with the order.
