On June 3, 2010, the Wisconsin Board of Nursing reconsidered the petitioner's request for full reinstatement of her practical nurse license pursuant to the order of the Board dated May 7, 2009. Based upon the information presented which shows that the petitioner has not completed the required length of time in compliance with the Board order to warrant full reinstatement and petitioner had a recent positive screen for prescription medications without a legitimate prescription on file with the Board, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for full reinstatement of the practical nurse license of TAMI PONSHOCK, L.P.N. (lic. # 308569-31) is hereby DENIED.

IT IS FURTHER ORDERED that petitioner shall submit an explanation for her positive screens for Tramadol and Butalbital and a copy of the prescriptions from a health care provider that prescribed the medications for her use.
