ORDER DENYING COMPLIANCE PLAN FOR REINSTATEMENT OF PRIVATE PRACTICE SCHOOL PSYCHOLOGY LICENSE

On October 6, 2010, the Respondent appeared before the Psychology Examining Board in support of his petition for reinstatement of his private practice school psychology license. Petitioner had previously surrendered his license, pursuant to the Final Decision and Order dated August 19, 2009, as result of audit findings which showed that petitioner had not completed the continuing education (CE) for renewal of his license in the biennium 2005-2007.

On May 12, 2010, the Board issued an order denying the petitioner's request for reinstatement of his license and ordered that he complete an additional preapproved twenty (20) hours of CE for the 2005-2007 biennium from a curriculum and provider acceptable to the Board to satisfy the forty (40) CE requirement for that biennium, and that he submit a plan for completion of the required CE for the 2007-2009 licensure biennium.

Based upon the information presented, the Board finds that petitioner has not fully satisfied the biennium 2005-2007 continuing education requirements; only thirty-five (35) CEs are acceptable due to disqualification of a five (5) credit course under Psy. 4.02(2)(d), Wis. Admin. Code.

Based upon the information presented, the Board finds that petitioner has not presented an acceptable plan for completion of the CE requirements for the 2007-2009 and the 2009-2011 bienniums.

Accordingly, the Board now finds and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for full reinstatement of the license of TIMOTHY P. KABARA (lic. #875) to engage in the private practice of school psychology in the state of Wisconsin is hereby DENIED.

IT IS FURTHER ORDERED that petitioner's plan for compliance, dated September 29, 2010, is hereby DENIED due to insufficient evidence that the courses listed in the plan meet the requirements in Psy 4.02(2) and do not constitute the number of CE hours required in Psy 4.02(1) for each biennium.

IT IS FURTHER ORDERED that petitioner's request to apply the remaining twenty (20) hours of CE from the provider *Ce4Less.com*, to the 2009-2011 biennium is hereby GRANTED.

IT IS FURTHER ORDERED that petitioner submit a new plan for compliance that consists of approved programs and courses, pursuant to Psy. 4.02(2), Wis. Admin. Code, in the number of credit hours set forth below:

- A) 2005-2007, a total of five (5) credits.
- B) 2007-2009, a total of 40 credits.
- C) 2009-2011, a total of 20 credits.

The monitor liaison shall approve the petitioner's plan of compliance with requirements prior to completion. A petition for reinstatement shall not be considered until documentation of proof of completion is received for the courses approved in paragraphs A and B above.
