#### PROCEDURAL HISTORY

On February 11, 2010, the Barbering and Cosmetology Examining Board (Board) issued a Disciplinary Order against Respondent, Laurie A. Lewis (Respondent). Pursuant to that Order, the Respondent was to pay a reduced forfeiture of \$500.00 within thirty (30) days of the Order date. By letter dated March 26, 2010, Laurie A. Lewis asked the Board to modify the order to include a payment plan. At its May 3, 2010 meeting, the Board reviewed the request, underlying Order and other materials submitted.

#### FINDINGS OF FACT

- 1. The February 11, 2010 Order provided that all payments and submissions required by the order be mailed or delivered to the Department Monitor, Division of Enforcement, Department of Regulation and Licensing, P.O. Box 8935, Madison, WI 53708-8935.
- 2. The Division of Enforcement Department Monitor reported to the Board that no payments had been received from the Respondent.
- 3. Based on the Respondent's failure to comply with the underlying Order, her request for modification should be denied.

#### CONCLUSIONS OF LAW

- 1. The Board has jurisdiction to act in this matter pursuant to Wis. Stats. s. 454.15.
- 2. The Respondent has violated the February 11, 2010 Order by not paying the forfeiture in the amount of \$500.00 as ordered.

THEREFORE, IT IS HEREBY ORDERED that Laurie A. Lewis' request that the Board modify its original Order to include a payment plan is denied.
