COLLEEN M. KLOSKE RESPONDENT. ORDER DENYING RESPONDENT'S REQUEST FOR PAYMENT PLAN AND ORDER SUSPENDING LICENSE

PROCEDURAL HISTORY

On September 14, 2009, Colleen M. Kloske (Respondent) was ordered by the Barbering and Cosmetology Examining Board (Board) to pay costs in the amount of \$150.00 and forfeiture in the amount of \$1,000.00 according to a specified payment schedule. On December 15, 2009, the Respondent petitioned the board for modification of the payment plan, requesting a plan to pay one hundred dollars per month. The Board considered this request at its May 3, 2010 meeting.

FINDINGS OF FACT

- 1. The September 14, 2009 Order provided that all payments and submissions required by the Order be mailed or delivered to the Department Monitor, Division of Enforcement, Department of Regulation and Licensing, P.O. Box 8935, Madison, WI 53708-8935.
- 2. According to the records and information presented by the Division of Enforcement Department Monitor, the Respondent has failed to make any payments.
- 3. The Respondent's request for modification of the Board's Order should be denied and an order of suspension should be issued based upon the Respondent's failure to comply with the terms and conditions of the Board's Order.
- 4. The Board's Order contains a provision that enables the Board to suspend the Respondent's license without further notice or hearing until Respondent has complied with the terms of the Order.

CONCLUSIONS OF LAW

1. The Board has jurisdiction to act in this matter pursuant to Wis. Stats. s. 454.15.

2. The Respondent is in violation of the Board's Order by failing to pay the costs and forfeitures as ordered.

THEREFORE IT IS HEREBY ORDERED that the Respondent's request for a payment plan of one hundred dollars per month is DENIED.

IT IS FURTHER ORDERED that the license of Colleen M. Kloske is hereby suspended until such time as she demonstrates to the Board or its designee that she has complied with the Board's September 14, 2009 Order.
