On September 16, 2009, the Medical Examining Board (Board) issued a Final Decision and Order prohibiting Dr. Thomas C. Johnson, M.D., from practicing medicine and surgery, under his Wisconsin license until he appeared before the Board and presented evidence sufficient to prove that he could practice with reasonable skill and safety to patients.

On July 21, 2010, the petitioner appeared before the Medical Examining Board, made a presentation and requested full licensure. The Board tabled the matter for further consideration until the August 18, 2010 meeting. Based upon the information of record, the Board now finds and orders the following:

**ORDER**

**NOW, THEREFORE, IT IS ORDERED** that the request of Dr. Thomas C. Johnson, M.D., (#20-41591) for full licensure be and hereby is, GRANTED.
