On March 30, 2010, the Wisconsin Pharmacy Examining Board granted Erin K. Orth an initial stay of the suspension of her pharmacist license, (#14955-40), retroactive to May 14, 2009, pursuant to the Board Order dated September 23, 2009. The Order provided that the stay is continuous contingent upon her compliance with the terms and conditions of the Board Order.

Information has been received by the Department Monitor that Erin K. Orth is in violation of the September 23, 2009 Order.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the stay of suspension is REMOVED and Erin K. Orth's pharmacist license (#14955-40) is SUSPENDED.

The stay shall not be reinstated until Erin K. Orth has been in compliance with the provisions of the September 23, 2009 Order for the most recent three (3) consecutive months.

This Order is effective five (5) days from the date hereof.
