On March 25, 2010, the Board of Nursing adopted the Proposed Decision in the above captioned matter and issued the Final Decision and Order suspending the Respondent's registered nurse license for a period of one year. When the Board issued the Final Decision and Order, it was not aware of certain inadvertent errors which occurred during the service by mail of the Proposed Order; errors which resulted in the Respondent's lack of notice of the proceedings. Based upon the information presented, including a request from the Administrative Law Judge who conducted the proceeding requesting that the Board rescind its decision, and the statement of the Respondent regarding her lack of notice, the Board now finds and makes the following:

### <u>ORDER</u>

NOW, THEREFORE, IT IS ORDERED that the March 25, 2010, Final Decision and Order in the above captioned matter is hereby RESCINDED and the registered nurse license of Respondent LINDA S. STONE, R.N., (lic. # 103865-30) is reinstated to full, active and unencumbered status.

IT IS FURTHER ORDERED that this matter is REMANDED to the Division of Hearings and Appeals for further proceedings to afford the Respondent an opportunity to answer the allegations of unprofessional conduct against her.
