#### PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Secretary of the Department of Regulation and Licensing. The Secretary has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Secretary adopts the attached Stipulation and makes the following:

#### FINDINGS OF FACT

1. Christenia N. Cogdill (DOB February 15, 1978) has an expired Wisconsin substance abuse counselor-in-training certificate (#14943-130). This certificate was first granted on September 28, 2006, and expired on February 28, 2009. Pursuant to Wis. Stat. § 440.08, Respondent can renew her certificate upon payment of a fee by February 28, 2014.

- 2. Respondent's most recent address on file with the Department of Regulation and Licensing is 5906 80th Street #12, Kenosha, Wisconsin 53142.
- 3. At all times relevant to this action, Respondent was employed by Genesis Behavioral Services, Inc.
- 4. Beginning on or about March 25, 2008 and continuing on through at least May 6, 2008, Respondent provided counseling services to Client AB.
- 5. On or about October 14, 2008, Respondent filled out a Department of Corrections Visitor Questionnaire on which she indicates that she is Client AB's girlfriend. This is a violation of Wis. Admin. Code §§ RL 164.01(2)(m) and (n).

#### **CONCLUSIONS OF LAW**

- 1. The Secretary of the Wisconsin Department of Regulation and Licensing has jurisdiction to act in this matter, pursuant to Wis. Stat. § 440.88(6), and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).
- 2. The conduct described in paragraph(s) 4-5, above, constitutes a violation of Wis. Admin. Code §§ RL 164.01(2)(m) and (n), and subjects Respondent to discipline pursuant to Wis. Stat. § 440.88(6).

#### **ORDER**

#### IT IS ORDERED:

- 1. The stipulation of the parties is approved.
- 2. The secretary accepts the surrender of the right of Christenia N. Cogdill to renew her substance abuse counselor-in-training certificate pursuant to Wis. Stat. § 440.08. In the event that Respondent attempts to renew her Wisconsin credential in the future, the Board will enter an order denying such application without further notice or hearing.
- 3. This Order shall become effective upon the date of its signing.
