

On June 3, 2010, the Board of Nursing considered the petitioner's request for modification of Final Decision and Order of the Board dated January 28, 2010, to reduce the frequency of her random drug screens. Petitioner is also currently ineligible for a stay of suspension pursuant to the terms of the Order. Based upon the information presented which shows that petitioner has not been in compliance with the Board's order for sufficient length of time to warrant a decrease in screens and is ineligible for a stay of suspension, the Board now finds and makes the following:

NOW, THEREFORE, IT IS ORDERED that the request for modifications and stay of suspension for LUANN K. RUSCH, R.N., (lic. # 81404-30) is hereby DENIED.
