On July 26, 2010, the Professional Counselor Section of the Marriage and Family Therapy, Professional Counselors and Social Work Examining Board considered the petitioner's request to surrender her license on the basis that she had stopped drug testing, was not employed and could not afford to continue testing in compliance with the Final Decision and Order of the section dated February 2, 2010.

The Section's order provided that the suspension would be stayed as long as petitioner remained in compliance with its terms and conditions for drug testing and monitoring of her AODA treatment. The order provided that the consequence of a failure to remain in compliance with the order is removal of the stay. The order further provides that upon submission of acceptable proof of compliance with the order, the petitioner's would be eligible for a stay of suspension. The complete surrender of the license was not contemplated under the terms of the order and would entail greater hardship upon petitioner should she desire to return to practice. Accordingly, the Board now finds and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request to surrender the license of LISA M. Berry, L.P.C., (lic. #3131-125) to practice as a licensed professional counselor in the state of Wisconsin is hereby DENIED.

IT IS FURTHER ORDERED that petitioner's license shall be SUSPENDED effective on the date signed below for failure to remain in compliance with the terms and conditions of the Board order and petitioner's license shall remain suspended until she submits proof that she has regained compliance with the order.
