#### PROCEDURAL HISTORY

On March 11, 2010, the Physical Therapists Affiliated Credentialing Board issued a Final Decision and Order revoking the physical therapist license of John T. Voelz. The revocation was based on two counts. First, practice during a suspension in violation of a November 29, 2007 Final Decision and Order, which was based on drug charges. Second, a felony drug conviction on September 2, 2008 for obtaining a controlled substance by fraud.

The March 11, 2010 Order provided that should Mr. Voelz ever seek to regain a credential he must pay all costs of the 2010 proceeding, he must provide sufficient evidence to the Board that he does not have any psychiatric or chemical abuse or dependency condition that could interfere with his ability to practice safely, and it shall be in the sole discretion of the Board whether to grant any credential to Mr. Voelz or whether to impose limitations on any such credential.

On July 21, 2010, the Board considered the petitioner's request for reinstatement of license. Based upon the information of record, the Board now finds and orders the following:

#### **ORDER**

**NOW, THEREFORE, IT IS ORDERED** that the request for reinstatement of license of John T. Voelz is DENIED based on insufficient evidence and based on the short length of time that has passed since the date of the order of revocation.

IT IS FURTHER ORDERED that the Board will not consider another petition for reinstatement from Mr. Voelz until at least six months from the effective date of this Order.

The effective date of this Order is July 8, 2010.
