On April 10, 2007, the Medical Examining Board (Board) granted Dr. Stephen Mason a limited license with certain requirements, including but not limited to, random drug screening, completion of fifty (50) hours of pre-approved Category I Continuing Medical Education, practice setting limitations, and a supervised work report requirement.

On May 30, 2009, the Board granted the petitioner's request to modify his limited license by reducing his random drug screens from twenty-eight (28) times per year to fourteen (14) times per year and approving a new therapist.

On May 19, 2010, the Board granted the petitioner's request to further modify his limited license by terminating the random drug screening requirement. The Board also ordered that once the petitioner supplied proof of obtaining a passing score on the SPEX examination, he could repetition the Board for further modifications. Based upon the information of record, including SPEX examination results indicating a passing score, the Board now finds and orders the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for full license of Stephen Mason, M.D., (#20-50257) be and hereby is, GRANTED.
