PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Department. The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Christine A. Bornemann, Respondent, date of birth October 24, 1972, was granted on January 31, 2008 certificate number 15511 as a Substance Abuse Counselor-in-Training. Respondent did not renew the certificate when it expired on February 28, 2009, but holds the right to renew it.
- 2. Respondent's most recent address on file with the Department of Regulation and Licensing is 1473 Crooks Street, Green Bay, WI 54301. The Division of Enforcement has determined that Respondent's current address is N5707 Railway Ave, Green Valley, WI 54127.

3. Respondent was employed as an AODA case worker at ACS Clinical Services Community Based Residential Facility (CBRF) in Green Bay. During April 2008, Respondent had sexual contact with a male resident of the CBRF who was her client. When the CBRF's administrators notified Respondent they wanted to interview her about her conduct, she immediately resigned her position on April 28, 2008.

CONCLUSIONS OF LAW

- 1. The Wisconsin Department of Regulation and Licensing has jurisdiction over this matter pursuant to Wis. Stat. § 440.88(6) and has authority to enter into this stipulated resolution of this matter pursuant to Wis. Stat. § 227.44(5).
- 2. Respondent, by having sexual contact with a client, has committed unprofessional conduct as defined by Wis. Adm. Code § RL 164.01(2)(m) and is subject to discipline pursuant to Wis. Stat. § 440.88(6).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED:

- 1. The right of Christine A. Bornemann, Respondent, to renew her certificate as a Substance Abuse Counselor-in-Training in the state of Wisconsin is hereby REVOKED.
 - 2. If Respondent ever makes application to the Department for any credential:
 - a. She shall provide proof sufficient to the Department that she does not suffer from any psychological condition which impairs her ability to function under that credential or may prevent her from practicing with reasonable skill or safety for patients and clients.
 - b. Whether to grant Respondent a credential and whether to impose any limitations or restrictions on any credential granted shall be in the sole discretion of the Department.
 - c. Respondent shall, prior to becoming credentialed, pay to the Department of Regulation and Licensing costs of this proceeding in the amount of \$450.00 pursuant to Wis. Stat. § 440.22(2).
