PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Margaret (NMN) Vizyak (D.O.B. 2/22/49) is duly licensed in the state of Wisconsin as a practical nurse (license # 28901). This license was first granted on 12/22/86.
2. On 6/27/08, Respondent was convicted of disorderly conduct in the Circuit Court for Waukesha County, in that on 11/29/07, when she was being conveyed to a hospital by officers at the request of her physician, she became angry that the officers would not convey her to the hospital of her physician's choice, and were instead conveying her to a different facility; she then physically resisted the officers. Respondent's sentence was withheld, and she was placed on probation for one year, on conditions that she engage in psychological evaluation and

any recommended treatment, and in AODA treatment, and not to consume or possess alcohol or other drugs unless prescribed by a treatment provider.

3. On 6/27/08, Respondent was convicted of bail jumping in the Circuit Court for Waukesha County, in that while out on bail related to the charges described in Finding 2, above, an on 5/22/08, Respondent consumed alcohol in violation of the conditions of her release. Sentence was withheld and Respondent was placed on probation for one year, with the same conditions as in the case described in Finding 2, above.

CONCLUSION OF LAW

By the conduct described above, respondent is subject to disciplinary action against her ~~license to practice as a nurse in the state of Wisconsin, pursuant to Wis. Stat. § 441.07(1)(c).~~

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the attached Stipulation is accepted, and:

1. The SURRENDER of the license of Margaret Vizyak to practice as a nurse in the state of Wisconsin is ACCEPTED.
2. Respondent shall not practice nursing in Wisconsin, including under the Nurse Licensure Compact, without a valid license from the Board.

IT IS FURTHER ORDERED that the COSTS of investigating and prosecuting this matter, in the amount of \$200, are WAIVED.
