On June 16, 2010, the Medical Examining Board (Board) ordered a limitation upon the license of Michael N. #### **ORDER**

**NOW, THEREFORE, IT IS ORDERED** that, due to satisfactory completion of the Intensive Course in Medical Record Keeping offered by the Case Western Reserve University School of Medicine, the continuing education limitation on the license of Michael N. Mangold, M.D., (#20-32859) be and hereby is, REMOVED.
