PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Medical Examining Board. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Daniel M. Joyce, M.D., Respondent, date of birth August 6, 1957, is licensed and currently registered by the Wisconsin Medical Examining Board to practice medicine and surgery in the state of Wisconsin pursuant to license number 41156-20, which was first granted June 25, 1999.

- 2. Respondent's last address reported to the Department of Regulation and Licensing is 2794 Summerset Circle, Suamico, WI 54173.
- 3. Respondent's practice specialty listed with the Department is Emergency Medicine.
 - 4. Respondent has retired from the practice of medicine for medical reasons.

CONCLUSIONS OF LAW

1. The Wisconsin Medical Examining Board has jurisdiction to act in this matter, pursuant to Wis. Stat. § 448.02(3), and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the stipulation of the parties is approved.

IT IS FURTHER ORDERED that Daniel M. Joyce, M.D. will not reapply for licensure to practice medicine and surgery in the State of Wisconsin at any time in the future and that the Department of Regulation and Licensing will not process any application for renewal of the license of Daniel M. Joyce, M.D., from the date of this Order.
