PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

- 1. Tracy Ann Campeau (D.O.B. 12/29/1965) is duly licensed in the state of Wisconsin as a practical nurse (license # 302351). This license was first granted on 11/16/1999.
- 2. On 4/14/2010 Respondent pled no contest in the Circuit Court for St. Croix County, Wisconsin, to the charge that she, as an employee of Deerfield Care facility, violated Wis. Stat. § 943.39(1) by knowingly falsifying or altering patient records by forging other nurses' signatures. Respondent's entries falsely represented that another nurse had signed as having witnessed her destroying controlled substances. Further proceedings were deferred under an agreement which allows this felony charge to be dismissed if Respondent successfully completes probation as set forth below, and surrenders her nursing license.

3. On 4/14/2010 Respondent was convicted in the Circuit Court for St. Croix County, Wisconsin on her plea of no contest to the misdemeanor charge of violating Wis. Stat. § 943.392 by altering medical records with the intent to mislead her employer. Respondent altered medical records by forging other nurses' signatures as witnesses to Respondent's having destroyed medication. Respondent was withheld, and Respondent was placed on probation for 6 months; she was to undergo random drug testing and maintain absolute sobriety as conditions of probation.

CONCLUSION OF LAW

By the conduct described above, Respondent is subject to disciplinary action against her license to practice as a nurse in the state of Wisconsin, pursuant to Wis. Stat. § 441.07(1)(b),(c), and (d), and Wis. Adm. Code §§ N 7.03(1)(b) and (2), and N 7.04(1), (2), (6) and (15).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the attached Stipulation is accepted, and:

- 1. The SURRENDER of the license of TRACY A. CAMPEAU to practice as a nurse in the state of Wisconsin is ACCEPTED.
- 2. Respondent shall not practice nursing in Wisconsin, including under the Nurse Licensure Compact, without a valid license from the Board.

IT IS FURTHER ORDERED that the COSTS of investigating and prosecuting this matter, in the amount of \$1050, are WAIVED, but may be imposed if Respondent ever applies for licensure.
