On July 22, 2010, the Board of Nursing reviewed correspondence from the Respondent, submitted in conjunction with the presentation of a Petition for Summary Suspension, in which Respondent indicated that she intended to surrender her license in lieu of further proceedings. Specifically, the Respondent wrote the following to the Department Monitor:

I feel that my best option is to surrender my nursing license... I have no money since I lost my job at Froedert. I have limited resources to get to therapy, lab draws, and AA. I feel that the best option for me is to surrender my license, get my feet back on the ground, and focus on continuing my sobriety.


Based upon the information presented which shows that the Respondent has voluntarily chosen to surrender her license, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED effective the date of this Order, the SURRENDER of the license to practice nursing of Jessica L. Maki, R.N., (lic.# 137462-30) is hereby ACCEPTED. Respondent shall not practice nursing in Wisconsin, including under the Nurse Licensure Compact, without a license from the Board. All rights and privileges afforded by virtue of the Respondent's nursing license are hereby null and void.

IT IS FURTHER ORDERED that if Respondent ever applies for a license from the Board, or petitions for reinstatement, she understands and agrees that it is wholly within the discretion of the Board to determine whether to grant a license to Respondent, and further to determine the terms and conditions of any license it may choose to grant.
