On July 22, 2010, the Board of Nursing considered the petitioner's request for a limited license for the purpose of completing a board-approved nurse refresher course. Based upon the information provided which shows that that petitioner has not reviewed her license within 5 years from the date of last renewal, she is required to complete a nurse refresher course.

ORDER

NOW, THEREFORE, IT IS ORDERED that a limited license shall be GRANTED to the petitioner LORI PRICHARD, R.N., (lic. # 202183-30) for the sole purpose of allowing her to complete a board-approved nurse refresher course. Petitioner may not engage in any form of nursing for compensation with this limited license which is solely for the completion of the clinical component of the nurse refresher course.

IT IS FURTHER ORDERED that this limited license shall expire within one (1) year from the date signed below. If petitioner has successfully completed the nurse refresher course, she may petition the board for reinstatement of her RN license. If she has failed to complete the course before the expiration of her limited license, she must reapply to the Board; reissuance of the credential shall be within the discretion of the Board.
