PROCEDURAL HISTORY

This matter comes before the Wisconsin Barbering and Cosmetology Examining Board (Board) as a citation Respondent Reginald J. Mims failed to pay. Based on the record in this case, the Board adopts as its Final Decision in this matter the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. Respondent Reginald J. Mims is licensed in the state of Wisconsin as a Barbering and Cosmetology Practitioner, license number 82-87564. This license was first granted to Mr. Mims on 08/23/2007 and it expired on 03/31/2009. This license was SUSPENDED 04/23/2009 for failure to pay child support and it remains suspended as of 06/25/2010.

2. The most recent address on file with the Wisconsin Department of Regulation and Licensing (Department) for Respondent Mims is 2024 West Brook, Madison, WI 53711.

3. On or about October 20, 2008, the Department received a consumer complaint alleging unlicensed practice at Jollof Beauty Shop in Madison, Wisconsin. A case was subsequently opened for investigation.

4. On March 11, 2009, a Department Investigator performed an inspection at Jollof Beauty Shop in Madison, Wisconsin. The inspection and investigation revealed that Jollof Beauty Shop was not licensed in the state of Wisconsin as a Barbering and Cosmetology Establishment.

5. The March 11, 2009 inspection revealed that Respondent Reginald J. Mims had been working at Jollof Beauty Shop since October 2008. Respondent Reginald J. Mims did not have a separate establishment or manager's license while employed at Jollof Beauty Shop.

6. On October 20, 2009, a Department Investigator mailed Respondent Reginald J. Mims a \$130.00 citation for working in an unlicensed establishment. The citation was mailed to the last known address for Respondent Mims, 2024 West Brook, Madison, WI 53711. The citation was returned to the Department. The citation was then sent to Mr. Mims at an address discovered in the Wisconsin Circuit Court Access System, 213 Tall Grass Trail, Sun Prairie, WI 53590. A true and correct copy of this citation is attached as **Exhibit A** and is incorporated herein by reference.

7. Respondent Reginald J. Mims has not paid the citation that was issued to him.

#### CONCLUSIONS OF LAW

1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15(2)(i).

2. By the conduct described in paragraphs 4 – 7 of the Findings of Fact, Respondent Reginald J. Mims has violated Wis. Admin. Code § BC 2.045(1) by working in an unlicensed establishment and not meeting the exceptions that allow services to be provided outside of a licensed establishment. As a result, Respondent Reginald J. Mims is subject to discipline pursuant to Wis. Stat. § 454.15(2)(i).

3. Respondent Reginald J. Mims is in default pursuant to Wis. Admin. Code § BC 10.07(1) for his failure to make a deposit or otherwise respond to the citation.

4. Pursuant to Wis. Admin. Code § BC 10.07(1), the Board has the authority to issue an order of default against Respondent Reginald J. Mims for the amount identified in the citation without further proceedings.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. Respondent Reginald J. Mims is in DEFAULT and shall pay to the Wisconsin Department of Regulation and Licensing a total forfeiture in the amount of ONE HUNDRED THIRTY DOLLARS (\$130.00) within twenty (20) days from the date of this Order.

2. Payment shall be made by certified check or money order, payable to the Wisconsin Department of Regulation and Licensing and sent to:

3. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a refusal to renew credentialing or additional disciplinary action.

IT IS FURTHER ORDERED that file 08 BAC 254 be, and hereby is, closed as to Respondent Reginald J. Mims.

4. This Order is effective on the date of its signing.
