Please take notice that under the authority of Wis. Stat. Chapters 227 and 444 and Wis. Admin. Code Chapters 192 to 196, the Department of Regulation and Licensing makes the following findings of fact, conclusions of law and order.

FINDINGS OF FACT

- 1. Calvin Maurice O'Neal is licensed as a professional Mixed Martial Artist in Wisconsin with license 12-277.
- 2. O'Neal participated in the Combat USA event of September 11, 2010. This event was held at the Oneida Bingo and Casino near Green Bay, Wisconsin.
- 3. O'Neal suffered a technical knockout, at 57 seconds of Round 1, as determined by the referee.
- 4. O'Neal was subsequently directed by the ringside physician to submit to a medical evaluation by the ringside physician before leaving the venue.
- 5. O'Neal left the venue without submitting to a medical evaluation by the ringside physician.

CONCLUSIONS OF LAW

- 1. By suffering a technical knockout, as described in finding of fact 4, O'Neal is subject to a mandatory medical suspension of 30 days as required by Wis. Admin. Code sec. RL 196.02.
- 2. By failing to submit to a physical examination as directed by the ringside physician, O'Neal violated Wis. Admin. Code sec. RL 195.01(3)(b).

- 3. Pursuant to Wis. Admin. Code sec. RL 106.02(3) and (4) a medical suspension shall not be cleared by the department until a contestant complies with all post-bout medical examination requirements.
- 4. The department has jurisdiction to take disciplinary action pursuant to Wis. Stat. Chaps. 227 and 444 and Wis. Admin. Code Chaps. 192 to 196.

ORDER

NOW, THEREFORE, IT IS ORDERED that the licensee of Mr. Calvin Maurice O'Neal is suspended for the mandatory period of 30 days, effective September 11, 2010, as required by Wis. Admin. Code sec. RL 196.02.

IT IS FURTHER ORDERED that the medical suspension of the license of Mr. O'Neal may not be cleared by the department until after a medical examination is conducted and Mr. O'Neal is cleared to compete.
