Please take notice that under the authority of Wis. Stat. Chapters 227 and 444 and Wis. Admin. Code Chapters 192 to 196, the Department of Regulation and Licensing makes the following findings of fact, conclusions of law and order.

FINDINGS OF FACT

- 1. Daniel Neil Grove is licensed as a professional Mixed Martial Artist in Wisconsin with license number 25-277.
- 2. Grove participated in the Bellator Fighting Championships, which was held on September 16, 2010. This event was held at the Rave (Eagles Ballroom) in Milwaukee, Wisconsin.
- 3. Grove was seen by the ringside physician, and it was determined that Grove had a possible boxers fracture in his right hand. Grove won his contest by a technical knockout in round one, against Alexey Oleinik, as determined by the referee.
- 4. Grove was subsequently directed by the ringside physician to report to the local emergency room for x-ray, splint and cast if needed.

CONCLUSIONS OF LAW

- 1. By suffering an injury as described in finding of fact 3, Grove is subject to a mandatory medical suspension as required by Wis. Admin. Code sec. RL 196.02.
- 2. Pursuant to Wis. Admin. Code sec. RL 196.02(3) and (4) a medical suspension shall not be cleared by the department until a contestant complies with all post-bout medical examination requirements.
- 3. The department has jurisdiction to take disciplinary action pursuant to Wis. Stat. Chaps. 227 and 444 and Wis. Admin. Code Chaps. 192 to 196.

ORDER

NOW, THEREFORE, IT IS ORDERED that the licensee of Mr. Daniel Neil Grove is suspended for the mandatory period of 30 days, effective as September 16, 2010, as required by Wis. Admin. Code sec. RL 196.02.

IT IS FURTHER ORDERED that the medical suspension of the license of Mr. Grove may not be cleared by the department until after a medical examination is conducted and Mr. Grove is cleared to compete.
