On October 6, 2010, the Wisconsin Barber and Cosmetology Examining Board received an application from Azher Syed Uddin with the business name of Divaa for an aesthetics establishment license.

FINDINGS OF FACT

- 1. Azher Syed Uddin has applied for an aesthetics establishment license located at 2500 Milton Avenue in Janesville WI 53545.
- 2. The establishment will be providing threading services only that will be performed by a licensed barber or cosmetologist or aesthetician.
- 3. The kiosk will have a self-contained water unit for sanitation purposes. Water would have to be replenished, and the dirty water gotten rid of, at a location in the mall away from the kiosk. The system described contains a 5 gallon clean water tank and a 6 gallon dirty water tank. One 5 clean water gallon tank is sufficient to supply clean water for two employees (barber or cosmetologist and/or aesthetician).

CONCLUSIONS OF LAW

- 1. The Wisconsin Barber and Cosmetology Examining Board has jurisdiction over this matter pursuant to Wis. Stat. § 454.08.
- 2. The Board has an obligation to protect the health and safety of Wisconsin consumers pursuant to State v. Aldrich, 71 Wis. 2d 206, 209 (1976).

ORDER

THEREFORE, IT IS HEREBY ORDERED THAT, Divaa, be granted an Aesthetics Establishment License subject to the following Limitation:

- 1. Divaa may provide threading as a service, but may not provide any other barbering and cosmetology service, aesthetics service, or any related services.
- 2. Only two employees may practice aesthetics in the establishment at a time.
- 3. The kiosk must remain in the same location in the mall.
