PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Pharmacy Examining Board. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Scott A. Vondra, R.Ph., (D.O.B.: September 27, 1962) is duly licensed as a pharmacist in the state of Wisconsin (license # 40-10954). This license was first granted on May 13, 1987.

- 2. Respondent's most recent address on file with the Wisconsin Pharmacy Examining Board is 424 Cardinal Circle, Apt. 8, Burlington, WI 53105.
- 3. At all times relevant to this action, Respondent was working as a pharmacist at Aurora Pharmacy #1215 in Racine, Wisconsin.
- 4. On or about April 27, 2009, Respondent diverted two (2) tablets of hydrocodone/APAP and one (1) Z-Pak (antibiotic) from stock at the Aurora Pharmacy #1215 in Racine, Wisconsin.

CONCLUSIONS OF LAW

- 1. The Wisconsin Pharmacy Examining Board has jurisdiction to act in this matter, pursuant to Wis. Stat. § 450.10, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).
- 2. The conduct described in paragraph(s) 4 and 5, above, constitutes a violation of Wisconsin Administrative Code § PHAR 10.03(1) and Wis. Stat. § 450.11(1).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that:

- 1. Scott A. Vondra, R.Ph. is hereby REPRIMANDED.
- 2. Respondent shall, within ninety (90) days from the date of this Order, pay a FORFEITURE in the amount of FIVE HUNDRED DOLLARS (\$500.00), pursuant to Wis. Stat. § 450.10(2).
- 3. Respondent shall, within ninety (90) days from the date of this Order, pay COSTS of this proceeding in the amount of EIGHT HUNDRED DOLLARS (\$800.00).
- 4. All requests, notice, payments required by this Order shall be made payable to the Wisconsin Department of Regulation and Licensing, and mailed, faxed, or delivered to:

- 5. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the costs or payment of the forfeiture as ordered, the Respondent's license (# 40-10954) may, in the discretion of the board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of this Order.
 - 6. This Order is effective on the date of its signing.
