#### PROCEDURAL HISTORY

The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Pharmacy Examining Board. The Board has reviewed the attached Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

#### FINDINGS OF FACT

- 1. Joseph M. Conrad, R.Ph., (D.O.B.: December 13, 1947) is duly licensed as a pharmacist in the state of Wisconsin (license #40-8485). This license was granted on June 21, 1973.
- 2. Respondent's most recent address on file with the Wisconsin Pharmacy Examining Board is 6002 N. Sherman Drive, Indianapolis, IN 46220.
- 3. On or about April 25, 2008, Respondent performed an online license renewal for his pharmacist license. In so doing, he marked a box indicating he completed the required continuing education for the biennium beginning June 1, 2006 and ending May 31, 2008.
- 4. On or about October 6, 2008, a representative of the Department contacted Respondent as a part of a random continuing education audit and requested that he complete an attendance chart and provide copies of certificates of completion or attendance for each program. The deadline for providing the requested information was October 31, 2008.
- 5. As of March 9, 2010, Respondent had not provided the requested documentation regarding the continuing education credits for the 2006 2008 biennium.
- 6. On or about April 12, 2010, Respondent performed an online license renewal for his pharmacist license. In so doing, he marked a box indicating he completed the required continuing education for the biennium beginning June 1, 2008 and ending May 31, 2010.
- 7. On July 21, 2010, a representative of the Department contacted Respondent via telephone regarding the status of his obtaining the required continuing education credits at which time he advised that he did not have documentation or certificates to prove attendance at any continuing education courses for the 2006 2008 biennium or the 2008 2010 biennium.
- 8, Respondent has not lived in Wisconsin since 1979. Respondent has not practiced pharmacy for the past 31 years. Since March 1982, respondent has worked for Eli Lilly & Company in Indianapolis, IN.
- 9. Respondent does not plan on practicing pharmacy in the state of Wisconsin, has no present intention to return and has tendered the surrender of his license.

#### **CONCLUSIONS OF LAW**

1. The Wisconsin Pharmacy Examining Board has jurisdiction to act in this matter, pursuant to Wis. Stat. § 450.10, and is authorized to enter into the attached Stipulation and Order, pursuant to Wis. Stat. § 227.44(5).

### **ORDER**

- 1. The Board accepts the voluntary surrender of the license previously granted to Joseph M. Conrad, R.Ph. (license #8485-40).
  - 2. This Order shall become effective on the date of its signing.
