IN THE MATTER OF THE DISCIPLINARY PROCEEDINGS AGAINST

ORDER FOR SUMMARY SUSPENSION

MICHAEL L. RAYMOND, R.N., RESPONDENT.

Division of Enforcement Case No. 10 NUR 371

The Petition for Summary Suspension of October 27, 2010, noticed to be presented at 9:15 a.m. on November 4, 2010, came on for hearing before the Wisconsin Board of Nursing (Board) at the time and place noticed. Attorney Jeanette Lytle appeared for the Complainant, Department of Regulation and Licensing, Division of Enforcement. Attorney Michael Herbert appeared for the Respondent, Michael L. Raymond, who did not appear.

The Board having considered the sworn affidavit of paralegal Beth Cramton regarding service; the sworn Petition for Summary Suspension; the sworn affidavit of Detective Dean Artus and Consumer Protection Investigator Steven Rohland; and, having heard the arguments of counsel, hereby makes the following:

FINDINGS OF FACT

- 1. On November 1, 2010, Paralegal Beth Cramton served on Respondent the Notice of Petition for Summary Suspension, dated November 1, 2010, and the Petition for Summary suspension, dated November 1, 2010, by mailing a true and accurate copy of those documents by regular mail and certified mail.
- 2. Michael L. Raymond, R.N., Respondent, date of birth June 14, 1966, is licensed by the Wisconsin Board of Nursing as a registered nurse pursuant to license number 150051-30, which was first granted February 24, 2005.
- 3. Respondent's last address reported to the Department of Regulation and Licensing is 2398 Wisconsin Street, Oshkosh, Wisconsin, 54901-7812.
- 4. Division of Enforcement case number 10 NUR 371 was opened based on information received from the Oshkosh Police Department that Respondent was in possession of child pornography.
- 5. On January 29, 2010, the Oshkosh Police Department executed a search warrant at the residence of Respondent. A laptop computer was seized and turned over to the Department of Justice, Division of Criminal Investigations (DCI), for examination. DCI recovered from the laptop photographs of nude children, including at least five photographs

showing children engaging in sexual acts. In addition, DCI discovered photographs of a severely disabled girl, naked with buttocks, breasts and vaginal area fully exposed and visible. This girl was later identified by Respondent's wife as being a 13-year-old, former patient of Respondent, who he cared for in his home.

CONCLUSIONS OF LAW

- 1. The Wisconsin Board of Nursing has jurisdiction over this matter pursuant to Wis. Stat. § 441.07.
- 2. The Wisconsin Board of Nursing has authority to summarily suspend a license to practice nursing pursuant to Wis. Stat. § 227.53(3), and Wis. Admin. Code § RL 6.
- 3. There is probable cause to believe that Respondent has engaged in or is likely to engage in conduct such that the public health, safety or welfare imperatively requires emergency suspension of Respondent's license to practice nursing.

ORDER

IT IS ORDERED that the license of Michael L. Raymond, R.N., to practice nursing in the state of Wisconsin is summarily suspended, effective immediately upon Respondent receiving actual notice of this summary order or upon service of this summary suspension order upon Respondent under § RL 6.06(3), Wis. Admin. Code, whichever is sooner.

IT IS FURTHER ORDERED that this Order continues to be in effect until the effective date of a final order and decision in the pending disciplinary proceeding against Respondent, unless otherwise ordered by the Board.

IT IS FURTHER ORDERED that Respondent is hereby notified of his right, pursuant to Wis. Adm. Code § RL 6.09, to request a hearing to show cause why this summary suspension order should not be continued and is further notified that any request for a hearing to show cause should be filed with the Wisconsin Board of Nursing, 1400 East Washington Avenue, P.O. Box 8935, Madison, Wisconsin 53708.

IT IS FURTHER ORDERED that in the event that Respondent requests a hearing to show cause why the summary suspension should not be continued, that hearing shall be scheduled to be heard on a date within 20 days of receipt by the Board of Respondent's request for hearing, unless Respondent requests or agrees to a later time for the hearing.
