On November 4, 2010, the Wisconsin Board of Nursing granted Julienne Zittlow an initial stay of the suspension of her registered nurse license, (#96229), pursuant to the Board Order dated November 4, 2010. The Order provided that the stay is continuous contingent upon her compliance with the terms and conditions of the Board Order.

Information has been received by the Department Monitor regarding Julienne Zittlow's failure to meet the terms and conditions of the Board Order dated November 4, 2010. Julienne Zittlow has informed the Department Monitor that she is unable to continue testing due to economic reasons.

#### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED that the stay of suspension is REMOVED and Julienne Zittlow's registered nurse license (#96229-30) is SUSPENDED.

IT IS FURTHER ORDERED that the Julienne Zittlow shall not be eligible for reinstatement of the stay of suspension until such time as she regains compliance with the order.
