Please take notice that under the authority of Wis. Stat. Chapters 227 and 444 and Wis. Admin. Code Chapters 192 to 196, the Department of Regulation and Licensing makes the following findings of fact, conclusions of law and order.

### **FINDINGS OF FACT**

- 1. Jason Gignac is licensed as a professional Mixed Martial Artist in Wisconsin with license number 10-277.
- 2. Gignac was contracted to participate in the September 11, 2010 event of the State finals for Combat USA.
- 3. Gignac arrived for his report time for weigh-in at 7:26 p.m., approximately two and one half hours late.
- 4. Gignac failed to make his contracted weight when he weighed-in at 152 pounds, seven pounds over his contracted weight of 145 pounds.

### **CONCLUSIONS OF LAW**

- 1. By arriving late for his report time for weigh-in, Gignac has violated Wis. Admin. Code sec. RL 195.02(14) and may be subject to a suspension of up to 60 days and an assessment of costs and forfeitures by the department.
- 2. By failing to make his contracted weight, Gignac has violated Wis. Admin. Code sec. RL 195.02(15) and may be subject to a suspension of up to 60 days and an assessment of costs and forfeitures by the department.

3. The department has jurisdiction to take disciplinary action pursuant to Wis. Stat. Chaps. 227 and 444 and Wis. Admin. Code Chaps. 192 to 196.

### **ORDER**

**NOW, THEREFORE, IT IS ORDERED** that the licensee of Mr. Gignac is suspended for a period of 30 days, effective September 11, 2010, and ending October 11, 2010.

IT IS FURTHER ORDERED that Gignac must pay a forfeiture of \$200 within 30 days of the date of this order.

Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Department, in its discretion, may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of the costs as set forth above, the Respondent's license #10-277 may, in the discretion of the department or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of the costs.
