On December 2, 2010, the Board of Nursing adopted the stipulation of the parties in this matter and issued a non-disciplinary remedial education order. However, the language in the proposed order prepared by the Division of Enforcement inadvertently described the respondent's license as "limited," which is a formal disciplinary status subject to reporting to the national healthcare database. The parties intended to enter into a stipulation for a non-disciplinary remedial education order with the understanding that the Board would adopt an order consistent with the stipulation. Accordingly, the Board now finds good cause to correct the language in the order which was issued on December 2, 2010, and thereby to remove any reference to a license limitation.

ORDER

NOW, THEREFORE, IT IS ORDERED that the Final Decision and Order of the Board against KAREN A. REILLY, R.N., (lic # 123419-30) dated December 2, 2010, is hereby corrected to remove the reference to a limited license.

IT IS FURTHER ORDERED that page 4 of the original order has been replaced with a corrected page which removes the language referring to the limitation upon respondent's license.
