ORDER GRANTING LICENSURE CONDITIONED UPON COMPLETION OF CONTINUING EDUCATION REQUIREMENTS

On December 8, 2010, the Wisconsin Psychology Examining Board considered the application for licensure as a psychologist submitted by the applicant, KARIN FLODSTROM. The applicant has been actively licensed as a psychologist in the state of Illinois since 1990.

Pursuant to PSY 2.12(4) applicants who have been licensed for 20 years or more in another licensing jurisdiction that had requirements for licensure substantially equivalent to the requirements in this state at the time of original licensure, and who have never been disciplined by the licensing board of any jurisdiction, shall meet the requirements for licensure of s. Psy 2.01(1), (2), (6), () (10), (11) and (12). The continuing education requirements in Psy 2.01(12) are 40 hours of continuing education per biennium, of which 6 hours shall be in the topic of ethics.

The information presented shows that applicant has not fulfilled the continuing education requirements because the state of Illinois does not require continuing education. Accordingly, the Board now finds and orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the applicant, KARIN FLODSTROM, shall be granted licensure under the provision for a senior psychologist, conditioned upon completion of the biennium requirement of 40 hours of continuing education, of which 6 hours shall be in ethics.

IT IS FURTHER ORDERED that the applicant shall have an extension of time, after licensure is granted, to complete the continuing education requirements. The extension of time shall be until **September 30, 2011.**

Proof of completion of the continuing education hours shall be submitted to the board's designee prior to expiration of the extension as follows:

IT IS FURTHER ORDERED that this is a **non-disciplinary order** which is intended to allow the approval of her application for licensure conditioned upon her completion of the required continuing education.

IT IS FURTHER ORDERED that if KARIN FLODSTROM fails to complete the continuing education by September 30, 2011, she shall cease and desist the practice of psychology in the state of Wisconsin until such time as she receives a further extension of time for completion or has fully completed the hours.
