On December 8, 2010, the Wisconsin Psychology Examining Board considered the applicant's request for permission to retake the Examination for Professional Practice in Psychology (EPPP), the board-approved examination for licensure as a psychologist, pursuant to s. 445.045, Wis. Stat. and s. Psy 2.01(7), Wis. Admin. Code. The information of record indicates that the applicant was granted permission to retake the EPPP on multiple occasions and yet after six attempts has not achieved a passing score. The applicant is now seeking permission to retake the examination for the seventh attempt. Accordingly, based upon the specifics of the applicant's reexamination history, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the applicant's request to retake the examination is hereby DENIED on the basis that his repeated failure to pass the examination demonstrates a lack of foundational competency to practice psychology.
