On December 1, 2011, the Board of Nursing considered the petitioner's request for reinstatement of her surrendered license pursuant to the Final Decision and Order of the Board dated October 7, 2003. Based upon the information of record which shows insufficient evidence supporting stable recovery, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of the practical nurse license of Kimberly K. Mayer (22926-31) is DENIED

IT IS FURTHER ORDERED that Kimberly K. Mayer may not petition the Board for reinstatement until she demonstrates of a minimum of three months of compliance with the following:

- Enroll and participate in an approved drug and alcohol monitoring program. The approved program shall require the testing of urine specimens at a frequency of not less than 48 times per year and the testing of hair specimens at a frequency of not less than one time per year.
- Attend Narcotics Anonymous and/or Alcoholic Anonymous meetings at a frequency of not less than twice per week.
- Participate in a drug and alcohol treatment program at a treatment facility acceptable to the Board or its designee. The rehabilitation program shall include individual and/or group therapy sessions at a frequency to be determined by therapist but not less than twice per month.

IT IS FURTHER ORDERED that Kimberly K. Mayer shall submit with her petition a comprehensive evaluation including a fitness to practice statement done by a Board approved evaulator.

IT IS FURTHER ORDERED THAT at the time her practical nurse license is reinstated it will be for the sole purpose of completing a nurse refresher course due to the length of time since she last practiced nursing. Upon successful completion of the PN refresher course, the Board may in its sole discretion determine whether and under what terms and conditions further licensure may be granted.
