The Pharmacy Examining Board considered this matter at its meeting on June 1, 2011.

BACKGROUND

On June 12, 2002, the Board issued a Final Decision and Order suspending Mr. Lundstad's license to practice as a pharmacist in the State of Wisconsin, Pharmacist license #12304. That suspension is currently stayed, subject to certain conditions and limitations.

On September 3, 2010, the Board issued an Order which granted Mr. Lundstad the ability to work as a pharmacist in charge for 24 hours per week. The Order further required Mr. Lundstad to submit to drug and alcohol screens through an approved program at a frequency of not less than 48 times per year for urine screens and 1 time per year for hair screens. He was further ordered to provide any and all evaluations completed with regard to his sobriety and ability to perform as a pharmacist in Wisconsin which have not previously been provided to the Board. The Order also required Mr. Lundstad to comply with all other provisions of the Final Decision and Order of June 12, 2002.

On or about March 3, 2011, Mr. Lundstad petitioned the Board for full licensure status.

Based upon all the information of record, including periods of unemployment and failure to comply with the September 3, 2010 order, the Board orders the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that Mr. Lundstand's petition for full licensure status, be and hereby is, Denied.

IT IS FURTHER ORDERED that in recognition of Mr. Lundstad's efforts in Minnesota, the drug screen frequency shall be modified to require testing of urine specimens at a frequency of not less than twenty-four (24) times per year and testing of a hair sample not less than one (1) time per year. Mr. Lundstad shall submit to drug and alcohol screens at an approved program. Wisconsin Pharmacy Examining Board currently recognizes Affinity or FirstLab as approved programs.

IT IS FURTHER ORDERED that Mr. Lundstad must comply with all other provisions of the Final Decision and Order of June 12, 2002. Pursuant to such Order, the Board will not consider restoring the Respondent's license to full, unlimited status until "after completion of five years of practice of pharmacy in compliance with all terms and conditions of this Order, and a demonstration that respondent may practice pharmacy without condition or limitation with skill and safety to patient and public." Periods of unemployment do not count towards compliance with the Order. Provided Mr. Lundstad maintains continuous employment, based on the Board's calculations, the earliest he would be eligible for full licensure status would be approximately February, 2013.

IT IS FURTHER ORDERED that Mr. Lundstad may petition for modification of the Order after three months of demonstrating full compliance with the June 12, 2002 and September 3, 2010 orders, including work and therapy reports.
