On July 29, 2004, the Board of Nursing accepted the surrender of Thomas Jiardini's right to renew his registered nurse license and any right he may have to be granted a license as a nurse in the future. The Board of Nursing further ordered in the event he attempted to renew or reapply, the board may enter an order denying such application without further notice or hearing.

On June 17, 2008, the Board of Nursing granted petitioner a limited license for the sole purpose of completing a board-approved nurse refresher course. The Board further ordered he must remain in compliance with his urine screens and have no access to controlled substances in the workplace. The Board further ordered that upon verification of his successful completion of the refresher course, his request for full reinstatement of his registered nurse license will be resubmitted to the Board for consideration.

On December 10, 2010, petitioner completed a board approved nurse refresher course.

On February 24, 2011, the Board of Nursing considered the petitioner's request for full reinstatement of his registered nurse license. Based upon the information of record which shows petitioner working from December 13, 2010 to January 31, 2011, when he was terminated for mishandling of narcotics, in violation of the Board Orders dated July 29, 2004 and June 17, 2008, and failure to complete drug screens, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for REINSTATEMENT of the registered nurse license of THOMAS JIARDINI, R.N. (lic. # 115650-30) is DENIED.

IT IS FURTHER ORDERED that the status of the registered nurse license of THOMAS JIARDINI, R.N. (lic. # 115650-30) remains SURRENDERED.
