BACKGROUND

On August 18, 2004 the Medical Examining Board (Board) issued an order granting Curtis D. Ongstad, M.D., (47337-20) a limited license to practice medicine and surgery in Wisconsin. The limitation required Dr. Ongstad to arrange for a Wisconsin licensed physician to review the medical records of 10 of his obstetrical cases which he handled from the beginning stages of labor through delivery with the primary focus on the 2nd stage of labor. The limitation was to remain in effect until the petitioner provided the Board with proof of compliance.


On December 16, 2005, the Board issued an order denying the petitioner's request to remove the limitations from his license. On December 16, 2009, the Board denied the petitioner's second request to remove the limitations. Based upon the information of record, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request to remove all limitations from the license to practice medicine and surgery of Curtis D. Ongstad, M.D. (47337-20) be, and hereby is, GRANTED.
