On June 2, 2011, the Board of Nursing considered the petitioner's request for modification to the Final Decision and Order of the Board dated March 1, 2007 to complete a nurse refresher course. Based upon the information of record which shows compliance with the random drug testing, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for modification of the Board Order limitation upon the registered nurse license of Anne Graf, R.N. (# 93746-30) to allow her to complete a nurse refresher course within one year is GRANTED.


IT IS FURTHER ORDERED that notwithstanding the modification granted above, pursuant to the restrictions in the Board's March 1, 2007 Order, Ms. Graf's license is limited by the condition she may not provide patient care for any person not a member of her immediate family.

IT IS FURTHER ORDERED that she the frequency of drug testing remain at no less than 14 urine screens per year and one annual hair test.
