The Pharmacy Examining Board considered this matter at its meeting on December 15, 2010.

BACKGROUND

On April 9, 2008, the Board issued a Final Decision and Order wherein the Board approved a stipulation entered into between the Respondent and the Department of Regulation & Licensing regarding an open investigation into misconduct by the Respondent, accepting the surrender by the Respondent of his license to practice pharmacy in the state of Wisconsin, Pharmacist license #10181-40, and accessing costs.

On or about November 16, 2010, Mr. Isaacson petitioned the Board to reinstate his Wisconsin pharmacy license.

Based upon all the information of record, the Board orders the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that Mr. Isaacson's petition to have his license to practice pharmacy in Wisconsin is Denied. Respondent may re-petition the Board for reinstatement if the conditions delineated below are met.

1. Respondent must take and pass the North American Pharmacist Licensing Exam (NAPLEX) and the Multistate Pharmacy Jurisprudence Examination (MPJE) within one year of the date of this order.

2. Respondent must complete not less than 15 credits of remedial education in Professional Boundaries and Ethics with no less than 6 credits in Professional Boundaries and 6 credits in Ethics pre-approved by the Department Monitoring Liaison. Credits taken to satisfy this requirement will not count towards the biennial continuing education requirements set forth in 450.085, Wisconsin Statutes. On-line courses will not be approved. Courses must be attended in person.
3. Respondent must continue treatment as recommended by the mental health provider approved by the Department Monitor and the provider must submit satisfactory reports on a quarterly basis.
4. Respondent must have documented participation in Narcotics Anonymous or Alcoholics Anonymous 12-step program meetings.
5. Respondent must continue with not less than 56 urine drug screens and 1 hair drug screen per year.
6. Respondent must submit satisfactory reports from his probation officer on a quarterly basis.
