On February 24, 2011, the Board of Nursing considered the petitioner's request for modifications to the Final Decision and Order of the Board dated July 26, 2007, to reinstate therapy requirement, terminate required attendance at AA/NA meetings, decrease drug screens and removal of work setting restrictions. Based upon the information of record which shows the petitioner to have an unsatisfactory work report and insufficient time under the Board Order, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for modification of the Board Order limitation upon the registered nurse license of CHERYL MILLER, R.N. (lic. # 30256-31) to reinstate the therapy requirement is GRANTED.

IT IS FURTHER ORDERED that petitioner's request for modification of the Board Order limitations to terminate required attendance at AA/NA meetings, decrease drug screens and remove work setting restrictions is DENIED.

IT IS FURTHER ORDERED that petitioner shall not petition the Board for modification for one (1) year from the date of this Board Order.
