The Medical Examining Board considered this matter at its meeting on June 15, 2011.

#### BACKGROUND

On August 15, 2007, the Board issued a Final Decision and Order suspending Ms. Nolden's license to practice as a physician assistant in the State of Wisconsin, license number 748. The Board granted a stay of the suspension effective May 18, 2009 contingent upon maintaining compliance with the terms and conditions in the August 15, 2007 Order. On August 10, 2010, the Board removed the stay and her license reverted to suspended status.

On or about May 26, 2011, Ms. Nolden petitioned the Board for a stay of the suspension. Ms. Nolden appeared before the Board, on June 15, 2011, in support of her petition.

Based upon all the information of record, the Board orders the following:

NOW, THEREFORE, IT IS ORDERED that Jennifer Nolden's petition for a stay of suspension, be and hereby is, Granted.
