The Pharmacy Examining Board considered this matter at its meeting on June 1, 2011.

### **BACKGROUND**

On April 9, 2008, the Board issued a Final Decision and Order suspending Mr. Van Buren's license to practice as a pharmacist in the State of Wisconsin, Pharmacist license #12259, but immediately stayed that suspension subject to certain conditions.

On or about April 11, 2011, Mr. Van Buren petitioned the Board to modify the Order by increasing the number of pharmacist in charge hours per week and a decrease in therapy sessions from monthly to quarterly.

Based upon all the information of record, including a supporting letter from his therapist, the Board orders the following:

### **ORDER**

NOW, THEREFORE, IT IS ORDERED that Mr. Van Buren's petition to be permitted to work as a Pharmacist in Charge for twenty-four (24) hours per week, be and hereby is, Granted. All other provisions of Paragraph C.22. of the Final Decision and Order shall remain in full force and effect.

IT IS FURTHER ORDERED that Mr. Van Buren's petition to decrease therapy sessions to once a quarter, be and hereby is, Granted. All other provisions of Paragraph C.4. of the Final Decision and Order shall remain in full force and effect.
