The Real Estate Board considered this matter at its meeting on April 28, 2011.

BACKGROUND

By Order dated February 23, 2011, the Real Estate Board ("Board") suspended the limited license of the Respondent, Lacinda G. Gerke-Edwards ("Respondent") for failure to comply with a prior Board Order. The Respondent, through her Attorney, Kristine Gerke, filed a Petition for Review wherein she requests that her license be immediately restored to regular status. The Department Monitor informed the Board that based on verbal conversations with the Respondent's Attorney, the Respondent modified her request. Instead of seeking reinstatement to full licensure, she is requesting that a 90 day stay of suspension be granted. Based upon all the information of record, the Board orders the following:

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED THAT:

1. the February 23, 2011 suspension of Lacinda G. Gerke-Edward's limited license (#90-38366) to practice as a real estate broker in the State of Wisconsin is stayed for a period of thirty days following the date this Order is signed.

IT IS FURTHER ORDERED THAT:

2. the Respondent shall cause a Certified Public Accountant to conduct an audit of any real estate trust account(s) owned or otherwise controlled by her to ascertain compliance with Wis. Admin. Code Chapter RL 18.

3. if the Respondent fails to submit to the Department Monitor the required audit, together with any supporting materials, demonstrating compliance with Wis. Admin.Code Ch. RL 18, the Stay of Suspension shall be lifted 31 days after the date this Order is signed.

This Order is effective on the date of signing.
