On December 1, 2011, the Board of Nursing considered the petitioner's request for modifications of the Final Decision and Order of the Board dated May 1, 2008 to decrease the frequency of drug screens and of the AA/NA meetings. Based upon the information of record which shows insufficient time under to warrant a reduction in the frequency of drug screens, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for modifications of the limitations on the registered nurse license of Shauna Dettinger, R.N. (#142093-30) to decrease the frequency of drug screens is DENIED.

IT IS FURTHER ORDERED that the modification to reduce the frequency of AA/NA meetings is DENIED because it is an adjunct to recovery.
