Due to an inadvertent scrivener's error, the previous order dated February 3, 2011, omitted the Board's action in regard to the removal of the stay of suspension. Accordingly, this Order is issued nunc pro tunc to correct the omission and replace the order dated February 3, 2011.

On January 27, 2011, the Board of Nursing considered the petitioner's request for a modification of the Final Decision and Order of the Board dated September 4, 2008, to reduce the frequency of her drug screens. Petitioner was scheduled to appear before the Board, but failed to do so and sent insubordinate email correspondence to the Department in regard to her appearance and drug testing compliance. Based upon the information of record which shows that the petitioner has not been in compliance with the terms and conditions of the Order, the Board now finds and makes the following:

#### ORDER

NOW, THEREFORE, IT IS ORDERED that the stay of suspension is REMOVED and the registered nurse license of PAULA M. SALKIN, R.N., (lic. # 84037-30) is hereby SUSPENDED.

IT IS FURTHER ORDERED that the request to reduce the frequency of the drug screens for PAULA M. SALKIN, R.N., (lic. # 84037-30) is hereby DENIED.

IT IS FURTHER ORDERED that petitioner shall not petition or appear before the Board for any reason prior to demonstrating three months of compliance.

IT IS FURTHER ORDERED that the Order requires petitioner to complete drug screens and that she is required to complete her testing on the date she is notified.

IT IS FURTHER ORDERED that further insubordination and non-compliance on the part of the petitioner provides cause for the Board to consider the need for a psychological assessment.

The suspension is effective as of February 14, 2011. The remaining terms of this order are effective of February 3, 2011.
