On January 27, 2011, the Board of Nursing considered the petitioner's request for modifications to the Final Decision and Order of the Board dated September 4, 2008, to terminate her therapy requirement, to eliminate the prohibition on her personal consumption of alcohol, to remove the direct supervision requirement for her nursing practice and decrease the frequency of drug screens. Based upon the information of record which shows that the petitioner has been in compliance with the terms and conditions of the Order but does not show therapist's support of the termination of treatment, the Board now finds and makes the following:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for modification of the Board Order limitation upon the registered nurse license of THERESA HINELINE, R.N. (lic. # 115776-30) to decrease the petitioner's urinalysis screens to twenty-eight (28) times per year with one additional annual random hair test is GRANTED.

IT IS FURTHER ORDERED that petitioner's request to terminate therapy, remove the restrictions involving personal consumption of alcohol and direct supervision is DENIED.
