The Pharmacy Examining Board considered this matter at its meeting on April 6, 2011.

#### **BACKGROUND**

On October 29, 2008, the Board issued a Final Decision and Order related to the disciplinary proceedings against Bonny M. Kimball, Pharmacist license #14533. Conditions and limitations are set forth in detail in such order. Specifically included in, but not limited to, such conditions and limitations include the following:

• Paragraph C.4: The rehabilitation program shall include individual and/or group therapy sessions at a frequency to be determined by Treater, but not less than once weekly for the first year of the stayed suspension. Therapy may end only upon a determination by the Board or its designee after receiving a petition for modification as required by D.4.

On or about March 2, 2011, Ms. Kimball petitioned the Board to modify the Order to reduce the required rehabilitation program including individual and/or group therapy to two times per quarter.

Based upon all the information of record, the Board orders the following:

### **ORDER**

**NOW, THEREFORE, IT IS ORDERED** that Ms. Kimball's petition to reduce the required therapy to two times per quarter, be and hereby is, Granted.
